Frank shared several important updates about the Camden County Workforce Board:

- Jeff was presented with the Harry L. Wheeler Professional of the Year Award at the GSETA Conference in October
- Three resolutions are pending for the Commissioners Meeting
- TANF participation rate has increased to 5.8%
- Office space is available at the One Stop for potential partners
- New cybersecurity school added to ITA options for customers

CHALLENGES DISCUSSED

- Government Shutdown Impact: Staff working without pay since September
- Medicare Cost Increases: Some recipients facing jumps from \$24 to \$1,200 per month
- Ongoing Issues: Housing and transportation challenges for clients with disabilities
