APPROVAL OF MEETING MINUTES

GUEST SPEAKER

Kristi Connors, NJDOL Manager, created the content for a video about the Camden County One Stop Career Center in 2020, which the NJDOL later adapted for use across the State's One-Stop Centers. She presented the video, which highlighted the Camden County One Stop's services for job seekers and employers. The facility offers a range of services including resumé building, interview preparation, training programs, career counseling, and support for specific groups such as veterans, older workers, and individuals with disabilities. Located in Cherry Hill, the center provides resources like computers, printers, and internet access, as well as hosting recruiting events to connect job seekers with employers.

WDB SUMMER YOUTH WORK EXPERIENCE PROGRAM 2025

Leslie noted the program successfully placed 100 interns this year, double the previous year numbers. With 30 employers participating in the Summer Youth Work Experience Program as Work-Learn Sites, there were 4 interns hired. Jeffrey Swartz highlighted the success of the Summer Youth Work Experience Program, which had a 98% completion rate.

SUCCESS STORY

- Leslie introduced Cynthia Primas, Director of IDEA Center for the Arts (***Institution for the Development of Education in the Arts***), who shared how her organization has been able to work with and hire previous Summer Youth Work Experience Program (SYWEP) participants. She described the IDEA's focus on developing 21st century skills through arts-based projects, including past SYWEP interns Diego Flores and Deshawn Casraiss.
- Cynthia presented her 2025 intern Damian Gandia's successful newsletter project for the IDEA Center, stating that Damian demonstrated strong collaboration and communication skills by interviewing students, staff, and artists to create a comprehensive newsletter that showcased the center's programs and opportunities.
- Damian Gandia thanked Cynthia and the WDB for the opportunity to be included in the program. He shared how meaningful it was to see the growth in his camp students and how much he enjoyed creating the 2025 IDEA newsletter. He hopes to return to IDEA again in the program's next term.
- The group celebrated Damian's achievements and Carl presented him with a Success Story Award.

COMMITTEE UPDATES

- Marlyn Kalitan presented a summary of the Literacy Committee's accomplishments for the year 2024-2025, including a name change (Pathways to Literacy), strategic planning, hosting a literacy event at Clementon Library, and installing a free library in the lobby at the One Stop Career Center. She mentioned the June presentation by educator and committee member, Heidi Daunoras, and Rishawn Davis of BookSmiles. BookSmiles founder, Larry Abrams, commented that his organization is seeking a larger facility to house the hundreds of thousands of books they will continue to distribute.
- Systems Performance reported significant growth in training providers, expanding from 25 to 41, and highlighted the success of the Summer Youth Program, which doubled in size to 100 interns.
- With the retirement of Gregg DeBaere, Operations Committee Chair, Carl offered comments on committee challenges including grant processes, funding changes, and skill barriers, while noting the expansion of the Summer Youth Program and efforts to address apprenticeship opportunities and policy shifts.

- As Chair of the Abilities Committee, Carl shared updates on their inclusive hiring initiatives, including a successful inclusive hiring webinar and upcoming events, and thanked the providers and employers for their participation in the committee.
- Ryan Thompson, the Business Service and Outreach Team Chair, emphasized their mission to build employer relationships and gather intelligence to match employees with job opportunities.
- Jill Roth-Gutman, Youth Investment Council Chair (Youth Committee), reported on the committee's efforts to strengthen youth engagement, including hosting the second Youth Advisory Board meeting. Joeliza Rosado was named Vice Chair of the committee and will serve as the liaison to the Youth Sub-Committee formed to amplify the youth voice. The committee collaborated with the Abilities and Literacy Committees to host the Pathways to Possibilities Resources Fair in Clementon.
- The WDB's Annual Report has been published and is available for download on the website, www.ccwib.com. The report provides performance data and highlights from the year.

CAMDEN COUNTY ONE-STOP UPDATE

Frank Cirii, Local Area Director of Operations

- Quarterly Performance and Budget Update**

Frank provided an update on organizational changes and performance over the past quarter. He reported that the organization conducted a SWOT (strengths, weaknesses, opportunities and threats) analysis and restructured divisions to become leaner and more staff cross-trained. New branding was implemented with staff shirts featuring QR codes. Performance data (included in the WDB Annual Report) showed strong results across most areas, with particular success in GED testing (averaging over 100 tests monthly) and WorkFirst (WFNJ) clients with over 50 showing recently (up from 5 in the past). The SJTA shuttle continues to provide transportation to the One Stop for services.

Frank highlighted a critical budget issue, noting that the organization has only been funded 50% of its budget and faces potential funding challenges starting October 1st if WFNJ money is not allocated soon, with a placeholder resolution set to expire the following day.

- Outreach Updates and Program Announcements**

Frank reported on recent outreach activities, including a successful job fair at Cherry Hill Mall where they distributed books through BookSmiles, and ongoing participation in county flu shot events. The organization is currently undergoing two DOL audits - an internal audit and a data validity audit led by Laurie Maguire.

CAMDEN COUNTY COLLEGE

Dr. Lovell Pugh-Bassett, President

- Camden County College announced a dental care program offering preventative services at minimal cost to clients and their families, which will be shared with the team via email.
